The show dates and times are Friday, September 19th 10am to 4pm and Saturday, September 20th 10am to 4pm. Booth sites will be marked. We are looking forward to seeing you!

VENDOR CONTRACT

Location: Mother Lode Fairgrounds, 220 Southgate Drive, Sonora, CA 95370

Dates/Times: Thursday, September 18,2025 10am to 5pm (vendor set up)
Friday, September 19, 2025 10am to 4pm (show open)
Saturday, September 20, 2025, 10am to 4pm (show open)

Booth space size: Single booth: 10 ft. deep by 10 ft. wide with two 8 ft. tables and 2 chairs.
Double booth: 10 ft. deep by 20 ft. wide with two 8 ft. tables and 2 chairs.

Booth rental fees: **\$150 per single booth; \$125 per additional booth.** For instance, \$150 for a 10X10, \$275 for a 10X20 (2 booths), \$400 for 10X30 (3 booths), or \$525 for a 10X40 (4 booths).
This fee covers set-up day Thursday, and the 2 days of the show.
IT IS NOT CHARGED Per Day; it is per booth.

Payment schedule: Signed contract and total fee amount are due no later than May 1, 2025.
Booths reservations are first come, first served, with payment
. This fee is non-refundable, unless the show is cancelled. If you find you are unable to attend, please let us know immediately and we will try to fill your space.
