The show dates and times are Friday, September 18th 9am to 4pm and Saturday, September 19th 9am to 4pm. Booth sites will be marked. We are looking forward to seeing you!

VENDOR CONTRACT

Location: Mother Lode Fairgrounds, 220 Southgate Drive, Sonora, CA 95370

Dates/Times: Thursday, September 17, 2026 9am to 5pm (vendor set up)
 Friday, September 18, 2026 9am to 4pm (show open)
 Saturday, September 19, 2026, 9am to 4pm (show open)

Booth space size: Single booth: 10 ft. deep by 10 ft. wide with two 8-foot tables and 2 chairs.
 Double booth: 10 ft. deep by 20 ft. wide with two 8-foot tables and 2 chairs.
 Triple booth: 10 ft deep by 30 ft wide, three 8-foot tables and 2 chairs.

Booth rental fees: **Early Registration—(PAID PRIOR to March 31, 2026)**
 \$150 per single booth.
Multiple booths, UP to a Max of 3 booths per vendor, are allowed at (\$150/booth, (10x10), \$300(10 x 20), \$450 (10 x30).

REGULAR REGISTRATION-- APRIL 1-June 1, 2026

\$200 PER SINGLE BOOTH

Multiple booths, UP to a Max of 3 booths per vendor, are allowed at (\$200/booth, 10x 10, \$400 (10 x 20), \$600 (10 x30).

This fee covers set-up days, Thursday, and the 2 days of the show.

IT IS NOT CHARGED Per Day; it is **per booth**.

Payment schedule: Signed contract and total fee amount are due no later than **June 1, 2026**.

Booth reservations are first come, first served, **with payment**.

This fee is non-refundable, unless the show is cancelled. *If you find you are unable to attend, please let us know immediately and we will try to fill your space.*
